Chronology:

On Thursday, June 17, 2020, Forest Rivers Office of Corporate Compliance ("OCC") was made aware of four incidents where the fifth-wheel "sliding down" due to a concern with the landing legs and the attachment to the chassis. The same day OCC launched an investigation into the concern. OCC met with the manufacturing plant the same day. It was discovered that the landing legs are purchased separately from the chassis and Forest River manufacturing installs them to the chassis.

On June 18, 2020, OCC learned there were seven complaints of the vehicle sliding down the landing leg.

On June 24, 2020, OCC spoke with the chassis supplier and they indicated that they were separating the bracket spacing further to allow for better engagement of the landing legs.

On June 26, 2020, OCC informed the Corporate Safety Committee of the investigation.

On July 1, 2020, the Corporate Safety Committee decided to recall.
