Noncompliance: Capacity (CCC) are understated on the certification label. Accordingly, these

vehicles do not comply with Federal motor vehicle safety standard (FMVSS)

Description of the Safety Risk: If the consumer is not aware of the actual trailer weight, there is a risk that

the trailer may exceed the towing capacity of the towing vehicle, increasing the risk of a vehicle crash. Because the GVWR and CCC are understated, there

is no risk resulting from trailer overloading.

Description of the Cause: The trailers were weighed incorrectly at the time of manufacture.

Chronology:

Mar. 18, 2020: During an audit of trailer weights and GVWR, Xtreme Outdoors weighed and discovered a potential error in measuring the trailers' dry weight and GVWR.

Mar. 20 to Jun. 8, 2020: Xtreme Outdoors shut down factory operations due to COVID-19, which suspended the investigation.

Jun. 8, 2020: Xtreme Outdoors resumed operations and continued its investigation of the potential error in determining the subject trailers' dry weight and GVWR.

Jun. 9 to Jul. 23, 2020: Xtreme Outdoors reviewed manufacturing records for the subject trailers to review trailer weights and potential changes in manufacturing that could potentially affect the trailers' weight. The investigation also looked at the weight and GVWR listed on manufacturer statements of origin (MSOs) to determine whether weights had changed over time. Xtreme Outdoors requested and received responses from dealers and customers that weighed subject trailers and found similar errors in the trailers' dry weight and GVWR.

Jul. 23, 2020: Xtreme Outdoors confirmed that the GVWR had been incorrectly measured on trailers that had left its control and, as a result, the GVWR and CCC listed on the subject trailers' certification label were incorrect. Accordingly, Xtreme Outdoors determined that the subject trailers do not comply with FMVSS 110 and 49 CFR Part 567.

Xtreme Outdoors is not aware of any accidents or injuries related to this noncompliance.

Description of Remedy:

Description of Remedy Program: Xtreme Outdoors will send new certification labels for all trailers affected by this recall. Unsold units that are outside Xtreme Outdoors' control will also be issued new MSOs with the correct information.
